

2023 Forensic Services and Clinical Consulting Fee Schedule for Hilary Sparrow, LPC

Expert Witness Testimony Fee - \$300 per hour (4-hour retainer required to begin services)

- Includes time for deposition, hearing, expert witness trial testimony, and/or and unforeseen court, private impromptu chamber meetings, settlement negotiations, delays, and recesses.
- Standard, reasonable and customary 4-hour retainer (\$1200) required upfront to begin services
- Time is billed against retainer and invoice will be sent if additional time is required

Pre-Trial Preparation: Case Materials Evaluation/Report Preparation - \$275 per hour (2 hour retainer required to begin services)

- Includes but not limited to document review, medical records review, report writing, pretrial preparation meetings, deposition meetings, and clinical and forensic consultation meetings
- Standard, reasonable, and customary 2 hour retainer (\$550) retainer required upfront. Time is billed against retainer and invoice will be sent if additional time is required

Independent Psychological Evaluation - \$275 per hour

- Includes medical record review, face time with patient, psychological testing with patient, interpretation of assessment results, and report writing
- Also includes written report and answers to requested interrogatories
- Interrogatories must be received in writing on attorney/law firm letterhead, before patient is scheduled

Travel - \$50 per hour

- Per hour of travel time round trip from home/office to deposition and/or testimony site
- Travel time is not applied if consulting services (trial, testimony, pretrial preparation, deposition, etc) are conducted over Zoom web meeting

Travel Expenses are billed to the client and reimbursed 100%

Travel expenses include (but are not limited to):

- mileage using International Revenue Service (IRS) business mileage 2023 rates
- Airfare
- parking expenses
- destination lodging expenses

Payment Terms and Cancellation Policy

Pre-Payment for expert witness services, deposition, trial, hearings, deposition and pre-trial preparation must be received at least 2 weeks before scheduled service.

- Cancellations: If scheduled services (deposition, hearing, trial, or preparation meetings) are cancelled within 1 week of scheduled service, 50% of all billable services will be charged. Services cancelled within 24 hours of scheduled date are billed at 70%.
- Invoices are sent through QuickBooks invoicing system with options to pay online through credit card, online through ACH, or pay by check.
