Our bill rates are based on Medicare allowable reimbursements, bill rates from on FairHealthConsumer.org (average cost for CPT codes in specific locations), [State of Colorado Workers' Compensation](#), and federal [Department of Labor Office of Workers' Compensation](#) (OWCP) for standard psychological procedures set by the American Psychiatric Association (APA), American Psychological Association, and the American Medical Association (AMA). Fee schedules also incorporates the US Bureau of Labor Statistics consumer price index (CPI) for [healthcare services](#) which shows a 4.1% increase from 2021-2022.

Federal OWCP and the state of Colorado have credentialed our practice as a "specialty clinic." We are trained in treating conditions of anxiety, post-traumatic stress, and trauma specifically for individuals within medicolegal systems. Our protocols, assessments, documentation, and treatment plans have been validated by federal and state entities and are admissible within judiciary systems.
